## Breeding Agreement

A. In consideration of \$\_\_\_\_\_ (\$\_\_\_\_\_ breeding fee and \$500 booking fee), Bill Cameron hereby agrees to breed his stallion, "Dun It For Money ", a buckskin stallion Registration# {AQHA Registration# 344636} to \_\_\_\_\_'s mare, Mare: \_\_\_\_\_, a \_\_\_\_\_ mare, Reg. #:\_\_\_\_\_.

B. \_\_\_\_\_ agrees to pay said amount on the dates indicated below:

C. In the event that \_\_\_\_\_'s mare does not take and become in foal, Bill Cameron agrees to breed said mare again for no additional charge at any time within 12 months from this contract date.

In the event that said mare does not deliver a **"live foal"**, Bill Cameron agrees to give \_\_\_\_\_ the right to an additional service to said mare at any time within 12 months from the last date of breeding said mare under this contract. Bill Cameron shall have no further liability hereunder for servicing said mare. **"Live foal"** as used in this agreement shall mean that the foal has stood and nursed from a mare for a period of at least 24 hours from time of birth.

D. \_\_\_\_\_ warrants that said mare is free from disease or infection that could be transmitted to said stallion, and agrees to provide and pay for a veterinarian certificate, showing such freedom of disease or infection and ability to be bred (fertility).

E. \_\_\_\_\_ agrees to assume the risk of injury, sickness or death to said mare except where caused by negligence of Bill Cameron, his agent's officer or employee.

F. \_\_\_\_\_ agrees to indemnify and hold Bill Cameron harmless for any loss or injury due to acts of said mare while on premises or under control of Bill Cameron except where caused by negligence of Bill Cameron.

G. If prior to breeding of said mare or after the mare has been bred but not come in foal, said stallion dies or becomes unfit for service as so declared by a licensed veterinarian, then this Agreement shall become null and void and all money paid by \_\_\_\_\_ shall be refunded.

H. Bill Cameron agrees to use reasonable care and caution for said mare while in his possession or control, pursuant to this Agreement and is authorized to obtain any necessary reasonable veterinarian or farrier care as required, but only after taking steps to contact \_\_\_\_\_ without success. Mare owner agrees to pay all veterinarian and/or farrier care required during the term of this agreement for said mare.

I. Bill Cameron agrees to provide and/or execute all the necessary documents of the registration of the offspring of the breeding.

J. Either party may, but need not, terminate this agreement for failure of the other party to meet any material terms of this agreement.
